Work Session: Local Improvement District – SE 9th St

The City Commission held a work session on May 14, 2019 regarding the reconstruction of N Main Ave and NW 7th Place. Staff recommended a follow up work session on a broader discussion of using Local Improvement Districts (LID) as a tool for financing the construction and/or rebuilding of local streets in poor condition. In addition, staff has identified SE 9th St as a primary candidate for a LID.

Below is a summary of the background and rationale for creating a LID at this location:

- SE 9th St is part of the SE Marlin business district and serves three businesses and a residence.
- There are 12 tax lots that have frontage on SE 9th St.
- The condition of SE 9th St is very poor. The street is approximately 600 feet long and has no pavement from SE Neptune heading east, curbs, sidewalks, or storm facilities.
- Any substandard city utilities identified in the CIP can be upgraded as part of a larger street project.
- A previous LID was proposed in the 1990s but did not move forward.
- All three commercial property owners have signed "non-remonstrance agreements" that compel the owners to participate in a LID based on a proportional share of street frontage. ORS 223 provides statutory authority and guidance on creating and assessing LIDs.
- Public infrastructure investment is a proven model to incent future development of the area.
- The City Commission recently adopted the Transportation System Plan. The City does not have a clear strategy for financing improvements nor does it have a proven history of applying and receiving grants for transportation projects. In addition, state and federal grants are typically

- awarded for ODOT owned facilities such as S Main Ave or Pacific Drive. Local streets, such as SE 9^{th} St, are the responsibility of local government.
- A financial model with or without incentives could be created to facilitate the reconstruction of other substandard streets identified in Warrenton's Transportation System Plan. SE 9th St is outside the urban renewal area (URA).

Before additional staff time is spent of pursuing the concept, staff is requesting direction on next steps.
