Mayor Henry Balensifer called the meeting to order at 5:30 p.m.

#### CONSENT CALENDAR

A. May 11, 2017 Budget Committee Meeting Minutes

Mayor Balensifer made the motion to approve the Consent Calendar as presented. Motion was seconded and passed unanimously.

<u>Page 86 – WBA</u> – Budget Officer Linda Engbretson noted the WBA has lowered their Urban Renewal matching funds for URA Façade Grant funds, due to the majority of funds not being used the past few years. WBA has also agreed to provide \$5000 for nuisance abatement. Also noted was a transfer of \$5,000 to the community center for furnace replacement.

<u>Page 49 – Community Development Department</u> – Community Development Director Skip Urling noted there is not much change from last year; and noted a minimal increase in personnel services due to cost of living increases; also noted a decrease from last year in application fees, due to LNG.

<u>Page 67 – Building Division Fund</u> – Mr. Urling noted this fund is similar to years past; pointed out line item 38 reduction, due to plumbing inspection expenses and contract costs for Mark Brien, the Plans Examiner.

<u>Page 51 – Fire Department</u> – Fire Chief Tim Demers noted the Fire department budget is basically a maintenance budget, and almost same as last year; with a 2.5% increase overall. He noted several vehicles are under a lease/purchase and one will be paid off in 2 years.

<u>Page 57 – Fire Apparatus Replacement</u> – Chief Demers noted the majority of this fund (\$12,000) is for air bottles (replacement); which have to all be replaced after 15 years; item was reduced from \$40,000 to \$10,000, and will build the fund back in coming years.

Warrenton Budget Committee Minutes - May 11, 2017 Page: 1 <u>Page 69 – Warrenton Marina Fund</u> – Harbor Master Jane Sweet noted not a lot has changed. Brief discussion followed on transient daily moorage, overnight stay rates and rate comparisons.

<u>Page 70 – Warrenton Marina Capitol Reserve Fund</u> – Ms. Sweet noted the power poles might increase as they need replacement due to age.

<u>Page 71 – Hammond Marina Fund</u> – Ms. Sweet noted no significant changes; workers comp difference is due to personnel changes. Brief discussion followed on moorage costs.

<u>Page 72 – Hammond Marina Capitol Reserve Fund</u> – Ms. Sweet noted the 3<sup>rd</sup> phase of bank stabilization carried over from last year; brief discussion followed on cost for the property acquisition.

Mayor Balensifer made the motion to approve the Budget Committee Action, Final Approval of the FY 2017/2018 Proposed Budget Document. Motion was seconded and passed unanimously.

There being no further business, Chair Mitchell adjourned the meeting at 6:06 p.m.

Regarding – Public Hearing on possible uses of *State Revenue Sharing Funds for FY*2018-2019

State Law requires that all cities participating in the State Shared Revenue Program conduct a public hearing before the budget committee in order to take public comment on the possible uses of the funds.

A pubic notice of the scheduled hearing was posted in *The Columbia Press* on April 27, 2018.

## **Budget Committee Action**

### Final Approval of the FY 2018-2019 Budget Document

Approval of the FY 2018-2019 proposed Budget Document, including amendments, by the Warrenton Budget Committee and submitting the approved Budget to the City Commission and recommending adoption.

WHEREAS, pursuant to Oregon budget law, and after careful consideration, Warrenton's Budget Committee has comprised and approved a balanced Budget for the City of Warrenton for FY 2018-2019;

WHEREAS, the proposed FY 2018-2019 Budget contains best estimates for projected revenues and expenditures; and

**WHEREAS**, the Budget Committee has reviewed all estimated revenues and expenditures, for all City Departments and funds, for FY 2018-2019, making modifications and changes where appropriate.

**THEREFORE, THE WARRENTON BUDGET COMMITTEE**, has approved and authorized the City to levy the permanent rate of \$1.6701 per-thousand of assessed value for the General Fund: to levy \$0.28 per thousand of assessed value for the Police Local Option Levy: to levy \$0.33 for the Library Local Option Levy: to levy the amount of \$578,631 for bonded debt for the wastewater treatment facility.

After completing all obligations required under Oregon Budget Law, the Warrenton Budget Committee hereby approves the *FY 2018-2019 Proposed Budget, as amended,* comprised of revenues and expenditures for all City funds and departments and submits the *Approved FY 2018-2019 Budget* to the City Commission for further consideration and recommended adoption.
