5. Public Hearings

A. CUP-25-2

B. CUP-25-3

Chair Moha started the hearing. The Commissioners disclosed that they had driven by the subject site, but they all believed that they could make an unbiased decision. They were not challenged. City Planner Jeff Adams gave the Staff Report. The Commissioners had questions of staff regarding whether the site had adequate parking to meet the code requirements.

The applicant was not present and did not give testimony. There were no members of the public there to speak for or in neutrality of the proposed vacation rental. Mr. Mark Simonsen had attended and spoke against the vacation dwelling.

The Commissioners then deliberated and spoke about the parking code requirements. They also touched on the need for long-term housing in the area versus short-term housing. It was

mentioned that the City had a lack of affordable housing and parking was already an issue around the unit. The Commissioners wanted more information regarding parking at the proposed vacation dwelling and it was mentioned that they would like the applicant to speak to the parking code requirements based off the property lines.
