Commissioner Ackley made the motion to approve the Consent Calendar as presented. Motion was seconded and passed unanimously.

Agency Director Linda Engbretson presented an amendment to Downtown Landscape Professional Services Contract with Beth Holland. She noted the original contract was not-to-exceed \$20,000 and the amendment now includes project management, for additional not-to-exceed \$20,000. Discussion followed on the cost and the need for an outside project manager. Commissioner Baldwin noted his concerns, stating an outside project manager is an unnecessary expense, as the landscapers contracted to install the plantings will have plans to follow. Ms. Engbretson stated she could narrow scope of work down in the contract to keep the costs down; and it was noted that if Ms. Holland does not oversee the project, Public Works Director Collin Stelzig would have to oversee it. Discussion continued on drainage and water build up around bulb outs. Mr. Stelzig noted the plans still need work on the grading and drainage issues.
