Commissioner Dyer made the motion to approve the Consent Calendar as presented. Motion was seconded and passed unanimously.

Executive Director Linda Engbretson stated that currently Urban Renewal provides a façade grant for the improvement of commercial buildings, and suggested offering a residential grant to help with the cost of cleaning up some of the residences in the district. She stated the Urban Renewal Advisory Board is very supportive of this idea; however after discussing with the consultant, it was noted that yard cleanup may not be allowable under the statute. Ms. Engbretson noted she sent it off for legal opinion and has not yet heard back. She stated she would like to put something in place for painting and façade maintenance. Discussion followed on grant/match options. Mayor Balensifer noted he would not be in favor of making these grant funds available to property owners that have had nuisance declarations. Ms. Engbretson noted this program could be an incentive for property owners to clean up before it gets to the nuisance stage. Discussion continued on criteria options and match options.

There was Commission consensus to move forward with a Residential Grant Program similar to the Commercial Façade Grant Program, and to add the cleanup aspect pending opinion from legal counsel.

Resolution URA 18-04

A RESOLUTION OF THE URBAN RENEWAL AGENCY OF THE CITY OF WARRENTON, CLATSOP COUNTY, OREGON MAKING MINOR PLAN AMENDMENTS TO THE WARRENTON URBAN RENEWAL PLAN

WHEREAS, the Urban Renewal Agency of the City of Warrenton finds it desirable to amend the Warrenton Urban Renewal Plan (the "Plan") to add projects under \$250,000 in estimated cost and to clarify projects to be undertaken in Section III.C, and

WHEREAS, ORS 457.085(2)(i) and Section VII of the Plan allows the Plan to be amended by resolution of the Agency unless the amendment is:

- Adding land to the urban renewal area, except for an addition of land that totals not more than one percent of the existing area of the urban renewal area.
- Increasing the maximum amount of bonded indebtedness excluding bonded. Urban renewal indebtedness issued to refinance or refund existing bonded indebtedness issued or to be issued under the urban renewal plan;
- Addition of a project other than those listed over \$250,000 in estimated cost...
- Extending the term of the Urban Renewal Plan for the District.

WHEREAS, this amendment may be adopted by resolution of the Agency;

NOW THEREFORE, BE IT RESOLVED by the Urban Renewal Agency of the City of Warrenton that the Plan be amended as shown in Attachment A.

B. TYPES OF PROJECTS

To encourage rehabilitation and redevelopment of commercial and residential land and aid in the retention of existing business and attraction of new businesses, the Renewal Agency may improve or construct public facilities and utilities including but not limited to streets, sidewalks, restrooms, marina docks, parking areas and pedestrian amenities. Improvements may occur within public rights-of-way, easements, or on public property. The Renewal Agency will work with public and private utilities to make the necessary modifications and adjustments to implement the objectives of the plan.

C. URBAN RENEWAL PROJECTS

The following projects have been identified to achieve the objectives *of* the Urban Renewal Plan. There is an overall need to improve the infrastructure in all of these areas to facilitate the proposed and potential new development and to encourage rehabilitation and redevelopment of the downtown, marina and residential areas.

1. Gateway Improvements

 Design and construct gateways to the Downtown and the Marina on S. Main Avenue and E. Harbor Street.

2. Public Improvements

- Inventory the public improvement deficiencies in the district including: storm drainage, streets, sidewalks, lighting, storm and sanitary sewer and water services.
- Based on the inventory begin a phased schedule to correct the deficiencies with storm drainage improvements in the downtown requiring the highest priority- but also including water improvements and sewer improvements throughout the Area, including but not limited to water line upgrades.
- Improve the downtown image and attractiveness by landscaping, benches, waste receptacles, lighting, art and other aesthetically pleasing amenities.

3. Pedestrian/Bicycle Improvements

- Provide pedestrian friendly streetscape improvements in the downtown. *Including but not limited to SW 4th Street and from the Harbor to the Highschool.*
- Develop bike and pedestrian trails with trailheads and restrooms, directional signage and rest areas.

4. Business and Residential Rehabilitation Programs

 Establish and manage low interest loan and small grant programs for businesses and residents to improve their appearance and condition. The Agency may establish policies and guidelines, and administer such loan and grant programs without amendment of the Plan.

5. Property Acquisition

 Acquisition and assembly of key properties for redevelopment. Projects are listed in detail by phase in the Urban Renewal Report.

6. Marina Improvements

- Prepare Master Improvement and Maintenance Plan
- Design and construct a fish cleaning station
- Design and construct Marina dock improvements.
- Design and construct public restrooms

7. Planning, Administration, and Planning Activities

• This project category authorizes any administrative expenses associated with the Area, any special studies that may be needed to develop the Area and any planning activities associated with such development, including but not limited to zone changes or master improvement plans.
